5. Presentation of Annie Sullivan Award

The IU Public Relations Consortium and the Pennsylvania Association of Intermediate Units jointly sponsor the Annie Sullivan Awards. This award recognizes an individual in education who exemplifies caring involvement with disabled students, and who has helped others in the community to understand and accept students with disabilities.

The 2006 Annie Sullivan Award recipient is Jenny Favata. Ms. Favata has been employed by the MCIU since 1973 and has worked in the Early Intervention program since its inception. Ms. Favata was described as being an extraordinary and selfless employee, the touchstone of the E.I. Department, and an asset to the organization. As a case manager she is recognized by both her colleagues and her clients for her dedication, professionalism and nurturing manner.

a. Dr. Jeanmarie Mason

Dr. Mason was pleased to report that there was an overwhelming response to the EI Quality Assurance Survey completed by the EI parents, with 98.5% of the survey respondents replying positively to the survey statements and 3% disagreeing with the statements. Phone calls were made to the 3% that were in disagreement to discuss the reason for their responses.

Dr. Mason informed the Board that the Division of Special Education has been reorganized to include an Assistant Director in lieu of a Program Director for Early Intervention. Ms. Maria DeLuca has been named as Assistant Director of Special Education.

b. Mr. Stan Wisler

Motion: It was moved by Ms. Martinez and seconded by Mr. Ted Miller that the Intermediate Unit Board approve both the 2005/06 Budget Transfers and the Recommendation to Approve the 2005/2006 Parent Transportation Contract.

Motion passed unanimously.

c. Dr. Lorie Stout

Dr. Stout reported that the new acts listed in her written report remain as stated, including Act 2A of 2006, the new Commonwealth Budget, and Act 114 of 2006, the omnibus education legislation.

Dr. Stout also thanked Jeffrey Sultanik, Esq., Bonnie Sheehan, Esq., and Kyle Berman, Esq. from Fox Rothschild, LLP for the excellent workshop they presented at the IU on Act 1 of 2006. The workshop was attended by 112 Montgomery County superintendents, school business officials, and school board members. Dr. Stout informed the board that the Legislative Services section of the MCIU website would be updated with timely information on Act 1 of 2006.

d. Ms. Holly Jobe

The Board was informed that Ms. Jobe was not present due to the death of her mother. The Board offered their condolences.

Ms. Maria Johns informed the board members that the recent Podcast workshop was well attended and gave a brief description of the MAGPI Users Group, the Internet 2 consortium organization which explores programs for use by schools.

e. Mrs. Elizabeth Weber

Mrs. Weber welcomed the new board members and gave a brief description of the Non-Public Schools Services division. In addition, Mrs. Weber highlighted the orientation session that was sponsored by the Montgomery County Health Department and the Montgomery County Emergency Medical Services Council regarding POD (Points of Dispensing) sites. Representatives from many schools attended the session.

Mrs. Weber also reported that the NPSS summer sessions have been very successful and well attended thus far.

f. Ms. Kate DiLullo

Ms. DiLullo welcomed the new board members and informed them that PaTTAN provides support and training for 42% of the special education students in the state of Pennsylvania.

Ms. DiLullo also reported that the National Autism Conference will be held from July 31-August 4, 2006 in State College. PaTTAN is a member of the national planning committee and PaTTAN staff members will be involved in the conference operations.
