7. Approval and Ratification of Bills as Included in the Treasurer's Reports

Ms. Knox presented the November, December and January Treasurer's Reports to the Board for approval. The cash balance as of January 31, 2009 was \$29,765,865.80.

Motion: It was moved by Mr. Sherpinsky and seconded by Dr. Baumgartner that the Intermediate Unit Board approve the November, December and January Treasurer's Reports and the payment of bills.

8. Human Resources Report

9. Reports of Staff

a. Dr. Jeanmarie Mason

Dr. Mason reported that IEP teams are meeting to determine what extended services will be provided for students with disabilities beyond the regular school year. Dr. Mason also reported that letters have been sent to the school districts informing them of their Fair Share for hosting MCIU Special Education classes as required by the Fair Share Plan and Agreement.

Dr. Mason brought attention to the letters and emails of commendation which are brought forth to the MCIU Board each month, stating that they are a strong testimony to the dedicated staff in the Special Education Division.

b. Mr. Stan Wisler

Mr. Wisler asked for approval on the following action items:

2. Recommendation to Approve an Agreement with Management Partnership Services (MPS) to conduct a Bucks and Montgomery County Transportation Study focusing on special education and nonpublic schools transportation. The administration recommends approval of an agreement with MPS in the amount of \$108,650.

3. Recommendation to Approve Agreements to Allow Vanguard as a 403(b) Provider with MCIU.

4. Recommendation to Approve an Agreement with Delaware Valley Healthcare Coalition (DVHCC) to take advantage of premium savings through wellness programs.

Special Education

1. Recommendation to Accept the Grant Award from PDE/Office of Elementary and Secondary Education for the Alternative Education for Disruptive Youth Programs at the Montgomery County Corrections Facility and the Anderson School, in the amount of \$112,908.00 for the period July 1, 2008 to June 30, 2009.

Motion: It was moved by Mr. Sattler and seconded by Dr. Baumgartner to approve all of the Action Items listed above.

Motion passed unanimously.

c. Dr. Mary Jane Gales

Dr. Gales reported that Senator Jane Orié introduced a bill that prohibits implementing statewide requirements for Graduation Competency Assessments unless they are sanctioned and funded by the General Assembly. Local Senators Dinniman, Greenleaf, Rafferty and Wonderling are co-sponsors of this bill. Representative Saylor has introduced a similar bill in the House. Local support is needed and Dr. Gales encouraged the Board members to contact their local legislators.

Dr. Gales recommended the PSBA video presentation entitled, “FREE” (Focus Resources on Educational Expenses) which is available on the PSBA website. The video features Tom Gentzel, Executive Director, and was initiated to free schools from the burden of unfunded mandates.

d. Mrs. Gail Kennedy

Mrs. Kennedy reported that the Technology & Information Services division is working collaboratively with Management Services and Mr. Steve Beck to write a grant for fire prevention and safety training for students and parents. TIS is also assisting Cheltenham School District with their search for a new Director of Technology.

e. Ms. Kendall Glouner

Ms. Glouner informed the Board that the Montgomery County Intermediate Unit hosted the annual Governor’s School for the Arts judging on January 20th. This program is on the Governor’s list of programs that will be eliminated due to budget constraints.

Ms. Glouner discussed the Penn State University study on local assessments, noting that the State Board of Education is holding hearings to provide an opportunity for Board members to listen to concerns and hear suggestions about ways to strengthen state high school graduation requirements.

f. Dr. Kenneth Voss

Dr. Voss reported that Nonpublic School Services staff, in collaboration with Curriculum, Instruction and Professional Development and Technology and Information Services staff have been conducting focus groups with nonpublic school principals to determine future allocations of Title II funding.

g. Dr. Janet Sloand

Dr. Sloand brought attention to the PA Department of Education Annual Conference brochure attached to her board report, noting that the theme for this year’s conference is *“Getting Results: Educating Students in a Standards Aligned System”*. The dates for the conference are April 14-17, 2009 and Mr. Michael Fullan, a nationally recognized speaker on school reform, is one of the keynote speakers.

h. Mrs. Kristen Rawlings

Mrs. Rawlings reported that a Zoomerang survey had been sent to the Board members to assess the effectiveness of the MCIU Communications Division's strategies. Mrs. Rawlings requested the Board members feedback.

10. Spotlight on an MCIU Division – Human Resources - Mrs. Jane Webster Mansuy

Mrs. Mansuy gave a PowerPoint presentation which highlighted the services that the Human Resources Division provides to the school districts and the support provided to external clients. Mrs. Mansuy serves as a liaison to PDE and provides consultation to districts on employment processes as well as training and certification issues related to Human Resources.

11. Report of the Solicitor

Mr. Sultanik had no report.

12. Report of the Executive Director

Dr. Shiveley's report included information on the federal stimulus package known as the American Recovery and Reinvestment Act (ARRA) which he brought back from the recent AASA conference. It is anticipated that school districts will receive funds in year one and have three years to spend it. There will be significant increases in Title I and Special Education funding.

Dr. Shiveley reported that the MCIU Services Provided booklets for 2007-2008 have been sent to each of the school district superintendents.

Dr. Shiveley expressed his gratitude to the Board members for providing their photographs for the conference room hallway.

Dr. Shiveley reminded the Board members that twelve positions will be open on the MCIU Board this year. The following school districts will be required to nominate a board member to serve on the MCIU Board effective July 1, 2009:
