4. Approval of Minutes of March 28, 2007

5. Public Comments on Agenda Items

Mr. Hasuik asked if there were any public comments regarding agenda items. Since there were none, the board proceeded with the agenda.

6. Approval of Bills as Included in the Treasurer's Report

Mr. Troy Miller presented the March Treasurer's Report to the Board in the absence of Marie Knox, Treasurer. The cash balance as of March 31, 2007, was \$31,730,890.79.

8. First Review of Proposed 2007/2008 Non-Public School Services Budgets

Mr. Wisler directed the Board members to the proposed 2007-2008 Non-Public School Services budget document, bringing attention to the new format which ties the numbers to the programs. Mrs. Betty Weber, with the assistance of Ms. Nancy Myers, Supervisor, Speech & Remediation, presented a program overview of the services offered through the Non-Public School Services division. A request for final approval of the NPSS budget will be requested at the May board meeting.

9. Reports of Staff

a. Dr. Jeanmarie Mason

Dr. Mason's report highlights the public relations efforts being made by the Special Education division. Dr. Mason and Dr. Cheryl Ranck, Manager of Early Intervention have been making an effort to visit a number of preschools in Montgomery County to offer information on Early Intervention and the resources available.

Dr. Mason also brought attention to the EI Improvement Plan listed in her report. PDE's Director of Special Education, Mr. John J. Tommasini, has recognized the MCIU's implementation of many changes in the administration of the early intervention program that raised the level of fiscal management in a positive manner while not compromising the quality of programs.

Dr. Mason also handed out Autism Awareness Ribbons, noting that April is Autism Awareness Month.

b. Mr. Stan Wisler

**Motion:** It was moved by Ms. Martinez and seconded by Mr. Chmielewski that the Intermediate Unit Board approve the Recommendation to Accept the 2007-08 Act 30 contracts with the following residential rehabilitative institutions (PRRIs) for the period 7/1/2007 - 6/30/2008 in the amounts indicated. c. Dr. Sharon Richardson

Dr. Richardson reported on the Accountability Block Grant Hearings, noting that there is an effort to expand the nine categories of usage to include world languages, laptop computer acquisition, high school reform, and elementary science curriculum. No new money is authorized for these additions.

d. Mrs. Gail Kennedy

Mrs. Kennedy highlighted the Technology Evaluations portion of her report, informing the Board that the TIS Division recently completed a technology evaluation for Perkiomen Valley School District. An evaluation will be conducted for Pottsgrove School District in May. Mrs. Kennedy gave special recognition to staff member, Maria Johns for her efforts and assistance with these projects.

e. Dr. Robert Shields

Dr. Peter Grande, Asst. Director of Curriculum, Instruction & Professional Development, reported in Dr. Shields' absence. Dr. Grande spoke about the recommended changes to the No Child Left Behind (NCLB) Act of 2001 released by PDE. He noted that the U.S. Department of Education has released final regulations regarding the creation of alternative tests of proficiency for students in special education as part of the state assessment systems.

f. Mrs. Elizabeth Weber

In addition to presenting the NPSS 2007-2008 budget for first review, Mrs. Weber brought attention to the letter of commendation in the board packet. The letter from The Hill School praises NPSS reading specialist, Terri Russo, for her professionalism and persistence.

g. Dr. Janet Sloand

Dr. Sloand reported that over 1,300 people attended the PDE Annual Conference, including general and special educators, administrators, therapists, and parents. Topics included Response to Intervention (RtI), students with disabilities, school safety, and inclusive practices.

Mr. Wisler offered a PowerPoint presentation on the topic of Co-Op Purchasing.

11. Report of the Solicitor

Dr. Shiveley reported on the AASA Legislative Conference he attended recently in Washington D.C. Based on discussions at the conference, Dr. Shiveley informed the Board that because of the federal government's attention to the war effort, congress needs to hear from the education sector regarding (1) IDEA Funding (2) E-Rate (3) Medicaid Funding (4) NCLB. Of note is the fact that Pennsylvania has three house members serving on the Education Committee.

The MCIU hosted a breakfast today to honor the Administrative Support Staff. The Bill Bainbridge Award was presented to Donna Kelly (Management Services), Louise Dager (Human Resources) and Linda Curran (Special Education).

The Superintendents' Retreat, organized and coordinated by Drs. Robert Shields and Peter Grande, is scheduled for April 26-28.

Dr. Shiveley reported that during his recent China trip, he had dinner with Mal Gran's son, David, and David's wife. The purpose of the trip sponsored by the Chinese Language Teachers Association of Greater New York was to facilitate an exchange program for students and staff.

The Voices of Inspiration Awards Banquet, co-sponsored by MCIU and Freedom Credit Union to honor Montgomery County teachers will be held on May 2, 2007 at Normandy Farms.
